#### C. Memorandum of Agreement

**WHEREAS**, negotiations have been ongoing between the Bargaining Team for the Board of Education of the Valley Stream Union Free School District 30 and the Bargaining Team for CSEA Local 1000, AFSCME, AFL-CIO Valley Stream Schools Custodial, Grounds and Maintenance Unit for a successor to the 2003-2007 Agreement between the parties; and  
**WHEREAS**, those negotiations have resulted in a tentative agreement for 2007-2009 contained in a Memorandum of Agreement, and  
**WHEREAS**, the membership of the Union has ratified the terms of the Memorandum of Agreement; and  
**WHEREAS**, the Board of Education has reviewed the terms of the Memorandum of Agreement and finds that a settlement consistent with the terms contained therein is in the best interest of the School District;  
**NOW, THEREFORE, BE IT RESOLVED**, that the Board of Education hereby approves and ratifies the terms of the aforesaid Memorandum of Agreement and hereby authorizes the President of the Board to execute a collective bargaining agreement consistent with the terms thereof.
