BOARD OF EDUCATION ELECTION RESULTS

(as reported in Board minutes)

“In connection with Chapter 979 of the Laws of 1957, the term of a school board trustee has been fixed at five (5) years. The statute further requires that members of the board be elected for such terms not in excess of five (5) years, so that as nearly as possible an equal number of members shall be elected to the board each year. See Section 2105, Education Law, subdivision 3,4, and 11”⁵
